Presidents Report:

Presented by the President - Sarah Rapsey.

Thank You everyone for coming along tonight. I am honoured to present the Presidents report for the 2024 Pathfinders Gymnastics Club Incorporated Annual General Meeting. This report reflects the achievements, challenges and future endeavours of our club over the past year.

Membership Growth:

I am pleased to report a significant increase of membership. Ending the year with 145 gymnasts in total, an increase of Recreational gymnasts by 91.6%, and an increase of competitive gymnasts by 200%. Overall athlete registration increased by 107% compared to the end of the previous year.

This is partially due the introduction of Trampoline and Homeschool classes which combined increased our membership by 45 athletes.

This growth is a testament to our dedicated coaches and volunteers, engaged members and the positive reputation of our club within the community.

Health & Safety:

We have had a strong focus on health and safety. We have continued to purchase and upgrade equipment, this has contributed to gymnast and staff safety as well as looking fantastic.

Safeguarding children is a high priority of Pathfinders, we ensure all of our coaches are up to date with the Gymnastics New Zealand safeguarding requirements.

We have a trained Safeguarding Representative and hope to have a second person complete a safeguarding lead course early this year.

Policies

- We have reviewed our Health and Safety, and Child Protection Policies, with a few minor changes.
- We have a new Policy folder that will be available for staff to have easy access to policies and policy updates. These are still available on our website.
- Induction Handbook for committee to be passed onto all new committee members.

Fundraising & Sponsorship

We were fortunate to receive the following grants and sponsorship:

- Waitaki District Council \$2500 Coach travel costs.
- Network Waitaki \$1000 beam leg protection.
- Lions Foundation \$10,000 beam project.
- Dooleys Masonry -\$600 for squad jacket uniforms.
- Mainland Spreading \$826.18 volunteer coach uniform.
- Aotea Electrical -\$515 equipment upgrades barrel and cartwheel mat.
- Dooley Consulting \$2,625 Financial advising.

We had one raffle this year. This generated \$ 3,609 which contributed towards upgrading parts of the floor area to improve safety.

<u>Centre Managers Report</u> - Presented by Sarah Rapsey on behalf of Suzie Ransby

Pathfinders had 22 gymnasts representing us at out-of-town competitions in 2023. Notably Keelee won the South Island Champs for Tumbling in her age group, Sophie placing 3 rd on Floor in apparatus finals at CSG Classic and Chelsea winning the Aoraki Trophy again for best overall score.

Squad trails at the end of 2023 were popular and we now have 35 gymnasts training towards representing Pathfinders. For the first time in many years, we will have a step 6 gymnast and a team of step 4 gymnasts which are goals we have been working towards since bringing in an additional squad coach and training more squad coaches up.

Recreational classes have all been moved to back-to-back slots on Thursdays so that we can work towards getting a team of dedicated and knowledgeable coaches providing our incoming gymnasts a fun and valuable experience. We have employed one new coach for all 3 classes and have made plans to employ another.

Our coaches have successfully completed their safeguarding training and look professional in the gym with their coach t-shirts and name badges.

In the gym we have created a larger sprung floor area to allow for more groups to train side by side safely. We have replaced most of the old heavy matting on the floor and will continue to fundraise

until this is completed. We have also purchased another air floor, some air barrels and a variety of small equipment for all gymnasts to use. We were fortunate to get the opportunity to replace a beam that had broken with a second hand one from CSG and to purchase protection sleeves for beam legs, we will continue to work towards making the beam area safer.

Adoption Of Annual Plan And Budget: Presented by Sarah Rapsey.

Moving into 2024 we continue our focus preparing for the inevitable move to a new building.

To make this a reality and affordable we hope to continue to grow our coaching team, registered athlete numbers and improve equipment.

Most of our classes are currently at capacity, with Beginner Recreational Gymnastics having a waitlist of 16 children. This is promising for the future of the club, unfortunately we currently do not have enough coaches to maintain extra classes. We have received a

grant from Gymnastics New Zealand and Otago Community Trust to the sum of \$630 to support us with coach and judge education.

Gymnastic New Zealand are introducing a new coach development framework, we are excited to learn what these changes may be as we prepare to grow our coaching team and encourage our coaches to undergo training and upskill.

We continue to prioritise upgrading equipment. This not only creates a safer environment for our athletes and coaches, as well as aiding in a quicker pack up, in the event that we find ourselves in a facility that does not allow us to keep equipment set up outside of class times.

We currently have two main equipment projects underway, these consist of upgrading the beam and floor areas.

We have been very fortunate to receive generous sponsorship from The Lions Foundation, with them giving us \$10,000 towards upgrading the beam area.

We have purchased a floor mat using funds from raffles and fundraising, this will be an ongoing project that we will continue to fundraise for.

We have been offered some opportunities for committee members to upskill in areas of finance and governance. These are webinars that are free to anyone who would like to take the opportunity to upskill and develop their knowledge. I encourage all committee members to take advantage of this opportunity, this is a great way to strengthen our governance team.

Recent events in the wider New Zealand gymnastics community remind us of the importance of having a strong safeguarding culture. We endeavour to continuously upskill in this area moving forward.
